

An order placed by the Buyer pursuant to a quotation is not binding on the seller (including any purported variation to these Terms & Conditions of sale contained in that order) unless and until such order is accepted by the seller. b) Prices in quotation on the seller's price list are subject to change without notice. 2. Prices & Taxes. a) Goods and Services Tax if applicable shall be to the Buyers account. b) All prices are in Australian Dollars, unless stated otherwise. 3. Cancellation of Order. a) Unless expressly provided in writing the Buyer shall have no right to cancel any order. b) without prejudice to any other rights the Seller may have, the Buyer shall indemnify the Seller for any loss, damage or expense incurred by the Seller should the Buyer cancel any order or part of an order. c) Custom and special products will incur a 50% cancellation fee. 4. Non Account Clients. Payment for all goods must be made in full prior to dispatch of order. A 50% deposit is required upon placement of the order, which acknowledges confirmation of order and acceptance of Terms & Conditions. 5. Acceptance. A) The Buyer shall be deemed to have accepted the goods to be of a description quality and quantity ordered unless particulars of claim of a claim to the contrary are notified to the Seller in writing within 7 days of receipt. BO Credits will be issued on the basis of inspection and comparison to the signed custom form. Credits will only be issued if the final product is different to the specifications on the custom form. c) in all other circumstances credits will not be issued for Custom or Special products. 6. Warranty. A) All implied conditions, warranties and undertakings other than those implied by Part V of the Trade Practices Act are expressly excluded. b) Where the goods are of a kind other than goods ordinarily acquired for personal, domestic or household use, then the Seller's liability for breach of a condition term or warranty implied by par V of the Trade Practices Act(1974) is limited, at its option, to anyone or more of the following. i) the replacement of the goods or the supply of equivalent goods; ii) tje repair of the goods; iii) the repayment of the cost of replacing the goods or acquiring equivalent goods, but excluding the cost of fitting those goods; iv) the payment of the reasonable cost of having the goods repaired. c) The Buyer expressly acknowledges and agrees. i) That the seller is not liable for any advise given by its agents or employees in relation to the suitability for any purpose of goods or materials supplied by the Seller and all such advice relied upon is at the Buyer's own rist; ii) that the warranty contained in 6a applies only within Australia.
